CHANGES MADE BY THIS TARIFF:

BASE ROUTE ADDED

Beginning at the private property of the Promenade at Granite Run (formerly Granite Run Mall), located in the Township of Middletown, thence via Middletown Road (PA Route 352), to the private property of Penn State University - Brandywine Campus; to be operated in the westbound direction.

Beginning at the private property of Penn State University - Brandywine Campus, located in the Township of Middletown, thence via Middletown Road (PA Route 352), Old Forge Road, private property of Fair Acres Geriatric Center, Old Forge Road and Middletown Road, to the private property of the Promenade at Granite Run (formerly Granite Run Mall); to be operated in the eastbound direction.

SPUR ROUTING ADDED (to be operated as required)

Beginning at the intersection of Middletown Road (PA Route 352) and Old Forge Road, located in the Township of Middletown, thence via Old Forge Road, private property of Fair Acres Geriatric Center; returning via the same route.

**ROUTE 114 – PENN STATE AND I-95 INDUSTRIAL PARK TO DARBY
TRANSPORTATION CENTER**

BASE ROUTE

Westbound:

Beginning at the Darby Transportation Center, located near the intersection of 9th & Main Streets in the Borough of Darby, thence via Main Street, Chester Pike (U.S. Route 13), Saville Avenue, 9th Street, Avenue of the States, 6th Street, Welsh Street, Pennsylvania Avenue, SEPTA private property of the Chester Transportation Center, Avenue of the States, 4th Street, Welsh Street, Avenue of the States, 9th Street, Engle Street, Concord Road, Dutton Mill Road, Pennell Road (PA Route 452), Concord Road, private property of Neumann University, Concord Road, Pennell Road, Baltimore Pike (U.S. Route 1), private property of Riddle Hospital, private property of the Promenade at Granite Run, and Middletown Road (PA Route 452) to the private property of Penn State University - Brandywine Campus, located in the Township of Middletown.

Eastbound:

Beginning on private property of Penn State University - Brandywine Campus, located in the Township of Middletown, thence via Middletown Road (PA Route 352), Old Forge Road, private property of Fair Acres Geriatric Center, Old Forge Road, Middletown Road, private property of the Promenade at Granite Run, Baltimore Pike (U.S. Route 1), private property of Riddle Hospital, Baltimore Pike, Pennell Road (PA Route 452), Concord Road, private property of Neumann University, Concord Road, Pennell Road, Dutton Mill Road, Concord Road, Engle Street, 9th Street, Sproul Street, 6th Street, Welsh Street, Pennsylvania Avenue, SEPTA private property of the Chester Transportation Center, Avenue of the States, 4th Street, Welsh Street, Avenue of the States, 9th Street, Saville Avenue, Chester Pike (U.S. Route 13), and 9th Street to the Darby Transportation Center, located near the intersection of 9th & Main Streets in the Borough of Darby.

ALTERNATE ROUTES (to be operated as required):

1. Beginning at the Darby Transportation Center, located near the intersection of 9th & Main Streets, in the Borough of Darby, thence via Main Street and MacDade Boulevard to the intersection of MacDade Boulevard & Chester Pike; to be operated in either direction.
2. Beginning at the intersection of Chester Pike and private property leading to Baldwin Towers, located in the Township of Ridley, thence via private property of Baldwin Towers Office Center and private property of Eddystone Crossings Shopping Center, located in the Borough of Eddystone.

SPUR ROUTE (to be operated as required):

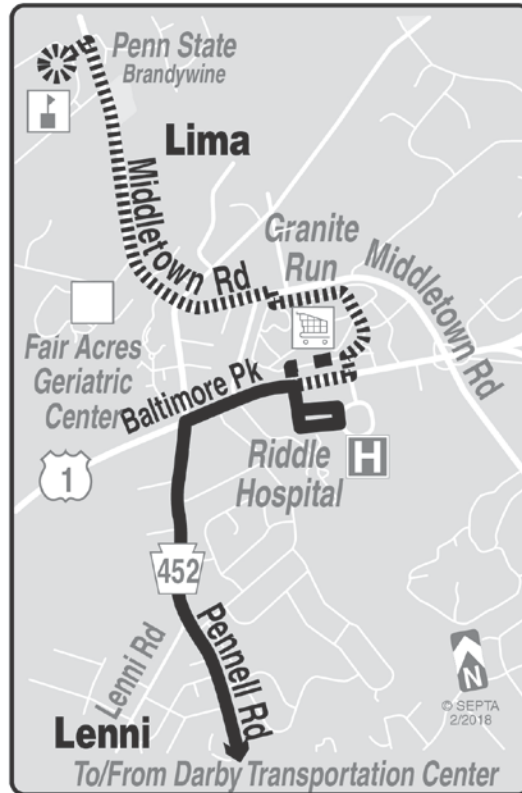
1. Beginning at the intersection of Concord Road & Bridgewater Road, located in the Township of Aston, thence via Bridgewater Road and Judy Way to private property of Elwyn's Bridgewater OTC facility; returning via the same route.
2. Beginning at the intersection of Middletown Road (PA Route 352) & Old Forge Road, located in the Township of Middletown, thence via Old Forge Road, private property of Fair Acres Geriatric Center, returning via the same route.

TURNBACK LOOPS (to be operated as required):

1. Beginning at the intersection of Concord Road & MacDonald Boulevard, located in the Township of Chester, thence via MacDonald Boulevard, Commerce Drive and MacDonald Boulevard to the intersection of MacDonald Boulevard & Concord Road.
2. Beginning at the intersection of 9th & Engle Streets, located in the City of Chester, thence via Engle Street, 7th Street and Yarnall Street to the intersection of Yarnall & 9th Streets.
