**CHANGES MADE BY THIS TARIFF:**

**ALTERNATE ROUTE ADDED (to be operated as required)**

Beginning at the intersection of Bristol Pike (U.S. Route 13) and the access ramp to Woodhaven Road (PA Route 63), located in the Township of Bensalem, thence via Bristol Pike and Newportville Road to the intersection of Newportville Road & Crossings Drive, located in the Township of Bristol; to be operated in either direction.

**Westbound:**

Beginning on private property of Oxford Valley Mall, located in the Township of Middletown, thence via Middletown Boulevard, North Buckstown Road, Oxford Valley Road, Lincoln Highway (U.S. Route 1 Business), Durham Road, New Falls Road, Bristol-Oxford Valley Road, Mill Creek Road, Green Lane, Elmwood Avenue, Norton Avenue, Beaver Dam Road, Beaver Street, Pond Street, Mill Street, Bath Street, Bristol Pike, private property of Bristol Park Shopping Center, Veterans Highway (PA Route 413, formerly New Rodgers Road), private property of the Bucks County Office Center, Veterans Highway, Wharton Road, Rittenhouse Circle, Wharton Road, Ford Road, Frost Road, Commerce Drive, Newportville Road, New Falls Road, Bensalem Boulevard, Bridgewater Road, Ford Road, Adams Road, Byberry Road, Knights Road, private property of Philadelphia Mills Mall (formerly Franklin Mills Mall), Millbrook Road, on-ramp to U.S. Route 13 (Bristol Pike), Bristol Pike and Frankford Avenue to SEPTA Private Property located near the intersection of Frankford Avenue and Knights Road, in the City of Philadelphia.

**Eastbound:**

Beginning on SEPTA Private Property located near the intersection of Frankford Avenue and Knights Road, in the City of Philadelphia, thence via Frankford Avenue, Bristol Pike (U.S. Route 13), access ramp to Woodhaven Road (PA Route 63), access ramp to Philadelphia Mills Mall (formerly Franklin Mills Mall), private property of Philadelphia Mills Mall, Knights Road, Byberry Road, Adams Road, Ford Road, Bridgewater Road, Bensalem Boulevard, New Falls Road, Newportville Road, Commerce Drive, Frost Road, Ford Road, Wharton Road, Rittenhouse Circle, Wharton Road, Veterans Highway (PA Route 413, formerly New Rodgers Road), private property of the Bucks County Office Center, Veterans Highway, private property of Bristol Park Shopping Center, Bristol Pike, Bath Street, Mill Street, Pond Street, Beaver Street, Beaver Dam Road, Plymouth Avenue, Elmwood Avenue, Green Lane, Mill Creek Road, Bristol-Oxford Valley Road, New Falls Road, Durham Road, Lincoln Highway (U.S. Route 1 Business), Oxford Valley Road, North Buckstown Road and Middletown Boulevard to private property of Oxford Valley Mall, located in the Township of Middletown.

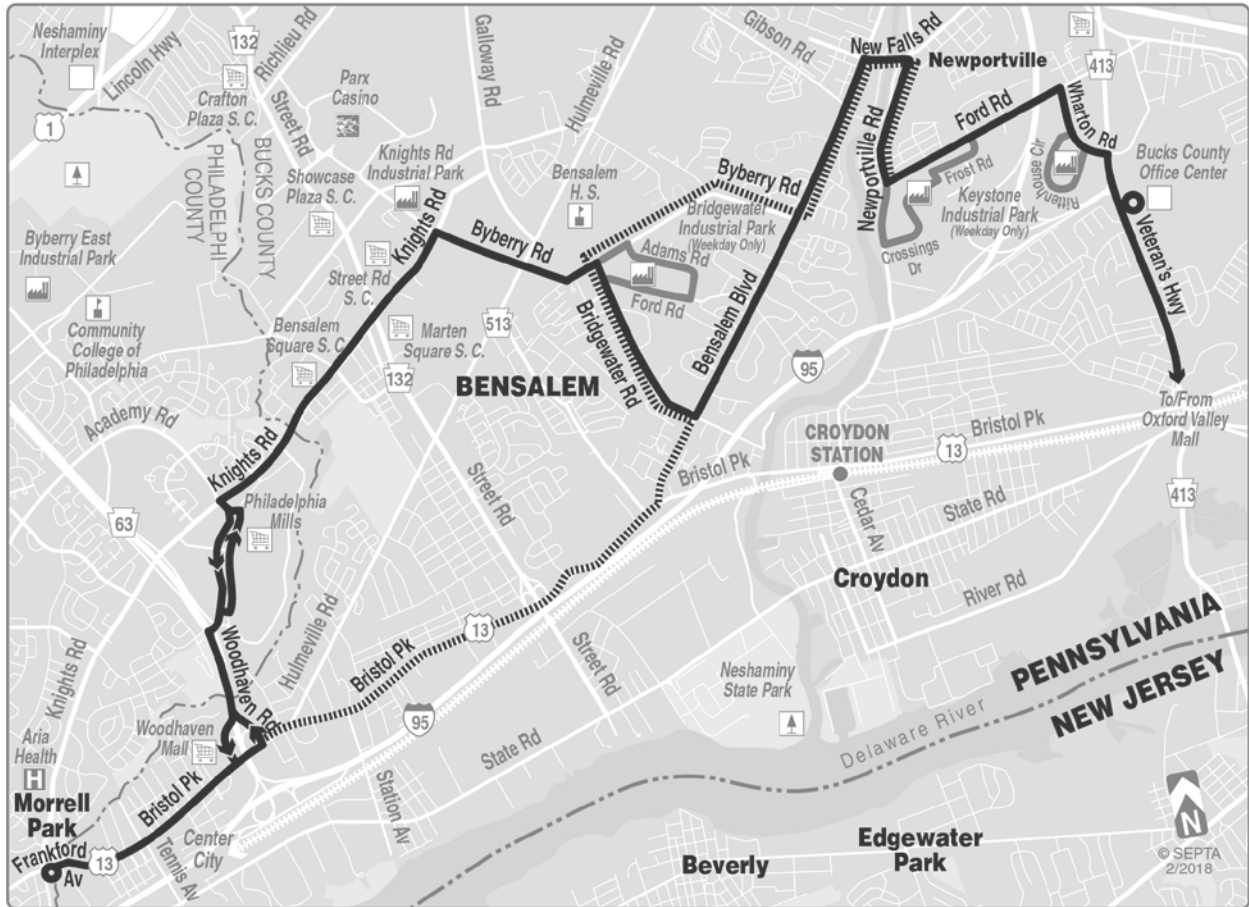
**ALTERNATE ROUTE (to be operated as required):**

1. Beginning at the intersection of Bristol Pike (U.S. Route 13) and the access ramp to Woodhaven Road (PA Route 63), located in the Township of Bensalem, thence via Bristol Pike and Bensalem Boulevard to the intersection of Bensalem Boulevard & Bridgewater Road; to be operated in either direction.
2. Beginning at the intersection of Bristol Pike (U.S. Route 13) and the access ramp to Woodhaven Road (PA Route 63), located in the Township of Bensalem, thence via Bristol Pike and Newportville Road, to the intersection of Newportville Road & Crossings Drive, located in the Township of Bristol, to be operated in either direction.
