CHANGES MADE BY THIS TARIFF:

BASE ROUTE DISCONTINUED (Eastbound)

Beginning at the intersection of State Highway Route 291(Governor Printz Boulevard) & Wanamaker Avenue, thence via Wanamaker Avenue, Powhatan Avenue and Jansen Avenue to the intersection of Jansen Avenue & State Highway Route 291 (Governor Printz Boulevard).

BASE ROUTE ADDED (Eastbound)

Beginning at the intersection of State Highway Route 291 (Governor Printz Boulevard) & Wanamaker Avenue, thence via State Highway Route 291 (Governor Printz Boulevard) to the intersection of Jansen Avenue & State Highway Route 291.

ROUTE 37 – SOUTH PHILADELPHIA TO CHESTER

BASE ROUTE

Westbound:

Beginning at the intersection of Snyder Avenue & Broad Street located in the City of Philadelphia, thence via Broad Street, Snyder Avenue, Passyunk Avenue, 61st Street, Lindbergh Boulevard, 84th Street, Bartram Avenue, Tincum Boulevard, 89th Street, private property of PNC Operations, 88th Street, Bartram Avenue, Industrial Highway, private property of Philadelphia International Airport, Industrial Highway, North Governor Printz Boulevard, Industrial Highway, 4th Street, PA Route 291, Welsh Street and Pennsylvania Avenue to SEPTA private property of the Chester Transportation Center located in the City of Chester.

Eastbound:

Beginning on SEPTA private property of the Chester Transportation Center located in the City of Chester, thence via Avenue of the States, 4th Street, Welsh Street, PA Route 291, 4th Street, Industrial Highway, South Governor Printz Boulevard, Industrial Highway, private property of Philadelphia International Airport, Industrial Highway, Bartram Avenue, 89th Street, private property of PNC Operations, 88th Street, Tincum Boulevard, Bartram Avenue, 84th Street, Lindbergh Boulevard, 61st Street, Passyunk Avenue and Broad Street to the intersection of Broad Street & Snyder Avenue located in the City of Philadelphia.

ALTERNATE ROUTE (to be operated as required)

Beginning at the intersection Passyunk Avenue & Essington Avenue located in the City of Philadelphia, thence via Essington Avenue, 70th Street, Holstein Avenue, 74th Street, Brewster Avenue, 78th Street, Holstein Avenue and Bartram Avenue to the intersection of Bartram Avenue & 84th Street; to be operated in either direction.

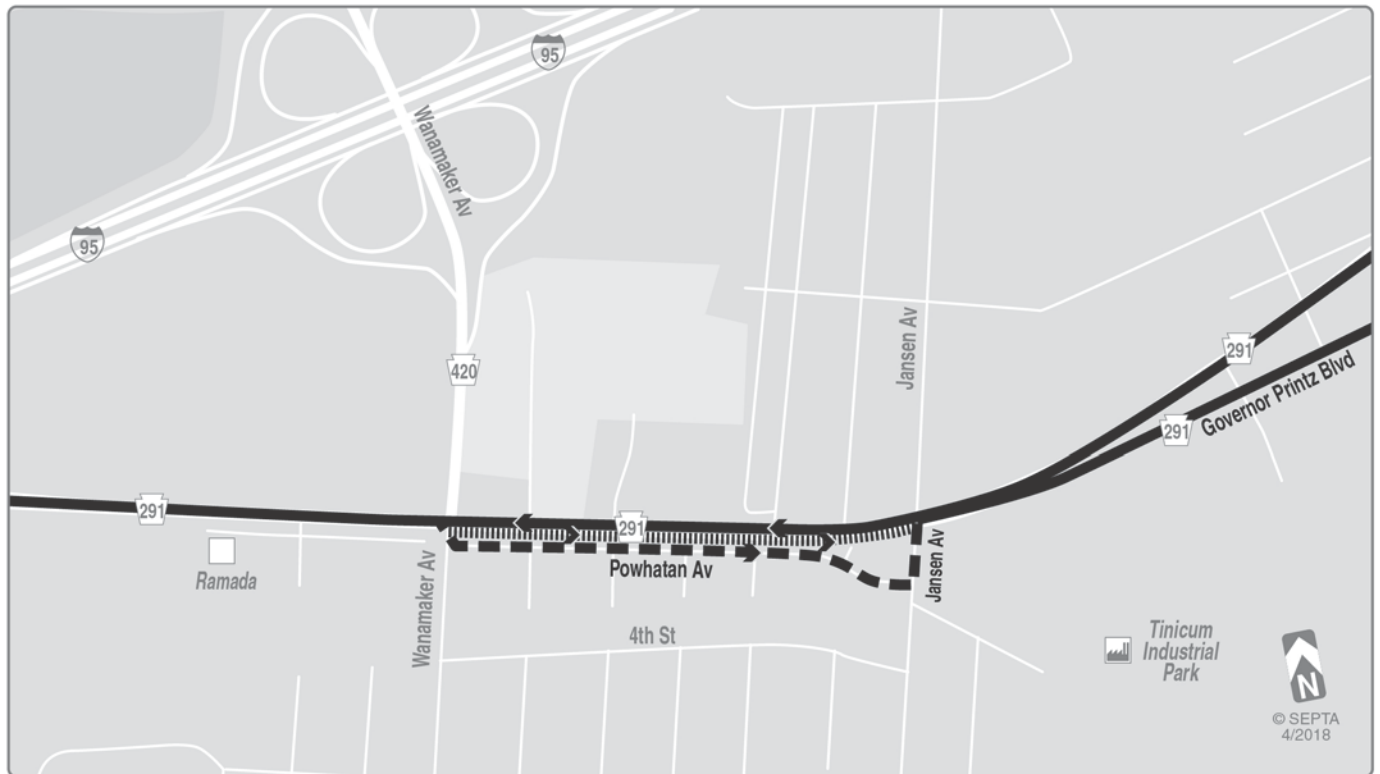
TURNBACK LOOP

Beginning at the intersection of Industrial Highway & Stewart Avenue located in the Township of Ridley, thence via Stewart Avenue, private property of The Boeing Company, and Sellers Avenue to the intersection of Sellers Avenue & Industrial Highway.
