CHANGES MADE BY THIS TARIFF:

Route 205 would be discontinued in total.

Portions of the route between Lancaster Avenue (U.S. Route 30) and Central Avenue and Swedesford Road and Chesterfield Parkway would continue to be served by a reconfigured Route 206. Refer to Tariff No. 169 concerning the routing for Route 206.

Portions of the route from the SEPTA private property of Paoli Regional Rail Station to the intersection of Lancaster Avenue and Central Avenue would continue to be served by Routes 204 and 206. Refer to Tariff No. 242 concerning the routing for Route 204.

Portions of the route between Lancaster Avenue and Greenwood Avenue and Lancaster Avenue and King Road westbound, as well as between Lancaster Avenue and King Road and Lancaster Avenue and the entrance to Paoli Regional Rail Station eastbound would also continue to be served by Route 92. Refer to Tariff No. 159 concerning the routing for Route 92.

Portions of the route along Chesterbrook Boulevard between Moore Road and Liberty Ridge Drive, and Moore Road between Chesterbrook Boulevard and Liberty Ridge Drive would continue to be served by Route 124. Refer to Tariff No. 206 concerning the routing for Route 124.

ROUTE 205 – CHESTERBROOK TO PAOLI STATION

BASE ROUTE

Northbound:

Beginning at the SEPTA private property of Paoli Regional Rail Station, located in the Township of Tredyffrin, thence via Paoli Plaza, Greenwood Avenue, Lancaster Pike (U.S. Route 30), Central Avenue, Industrial Boulevard, Cedar Hollow Road, Swedesford Road, Chesterfield Parkway, Swedesford Road, Duportail Road and Liberty Ridge Drive to the intersection of Liberty Ridge Drive & Morris Drive.

Southbound:

Beginning at the intersection of Liberty Ridge Drive & Morris Drive, located in the Township of Tredyffrin, thence via Morris Drive, Duportail Road, Swedesford Road, Chesterfield Parkway, Cedar Hollow Road, Industrial Boulevard, Central Avenue, Lancaster Pike (U.S. Route 30) to the SEPTA private property of Paoli Regional Rail Station.

SPUR ROUTE (to be operated as required)

Beginning at the intersection of Duportail Road and Morris Drive, located in the Township of Tredyffrin, thence via Duportail Road, Chesterbrook Boulevard and Lee Road to its terminus at Wilson Park; to be used in either direction.
